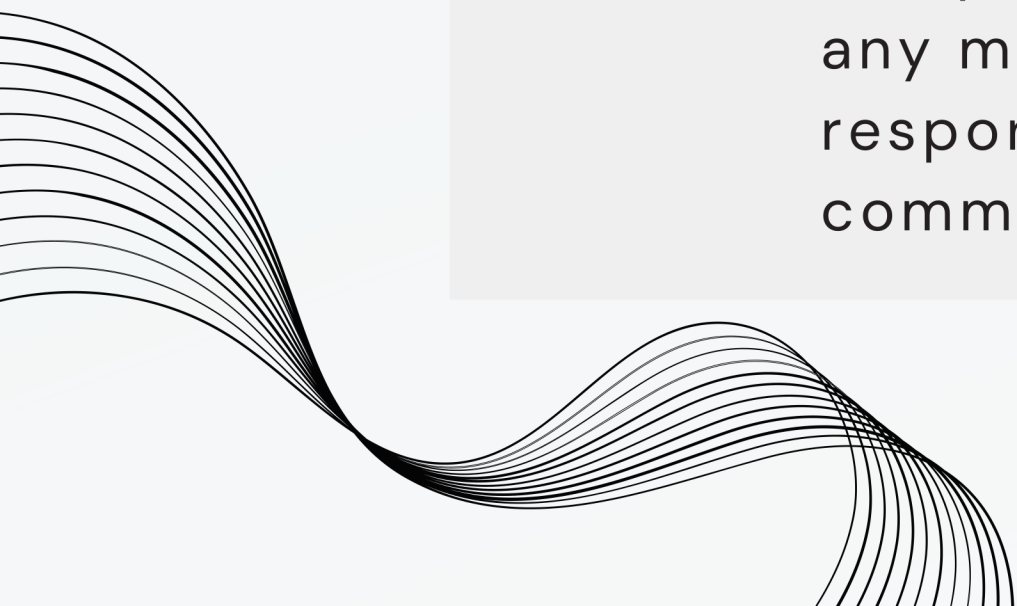
ROLES



President: chief executive and presiding officer - has general supervision, direction and control of the administration booster club, given majority vote. Ex-officio member of all committees.



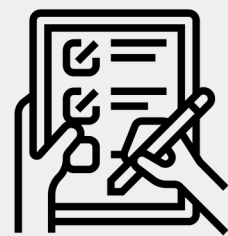

Responsible for overseeing any media used and shall oversee any volunteers or committees responsible for promotion, media, websites, or any other form of communication to the general public and club members.



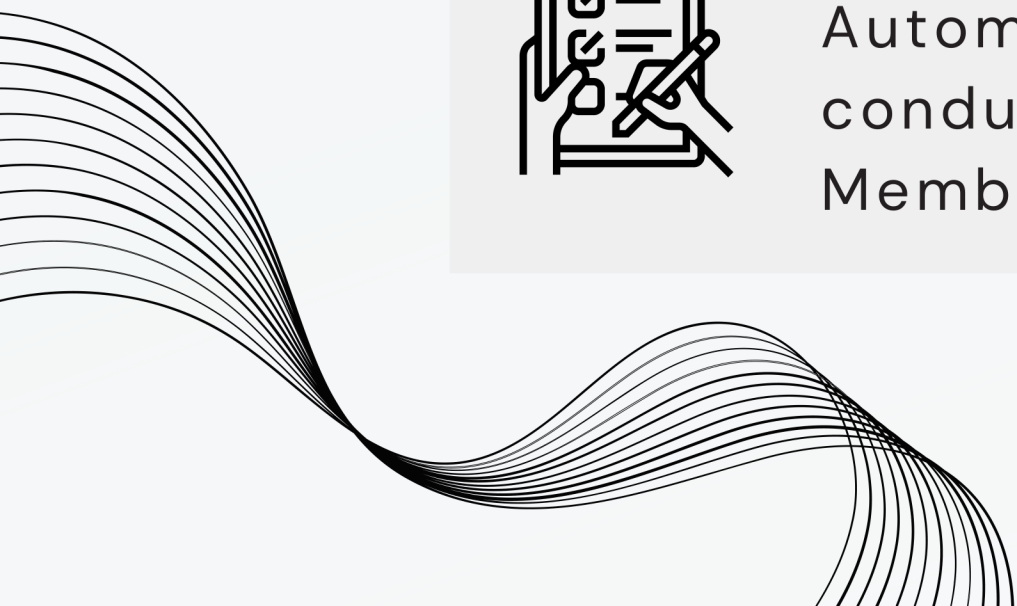
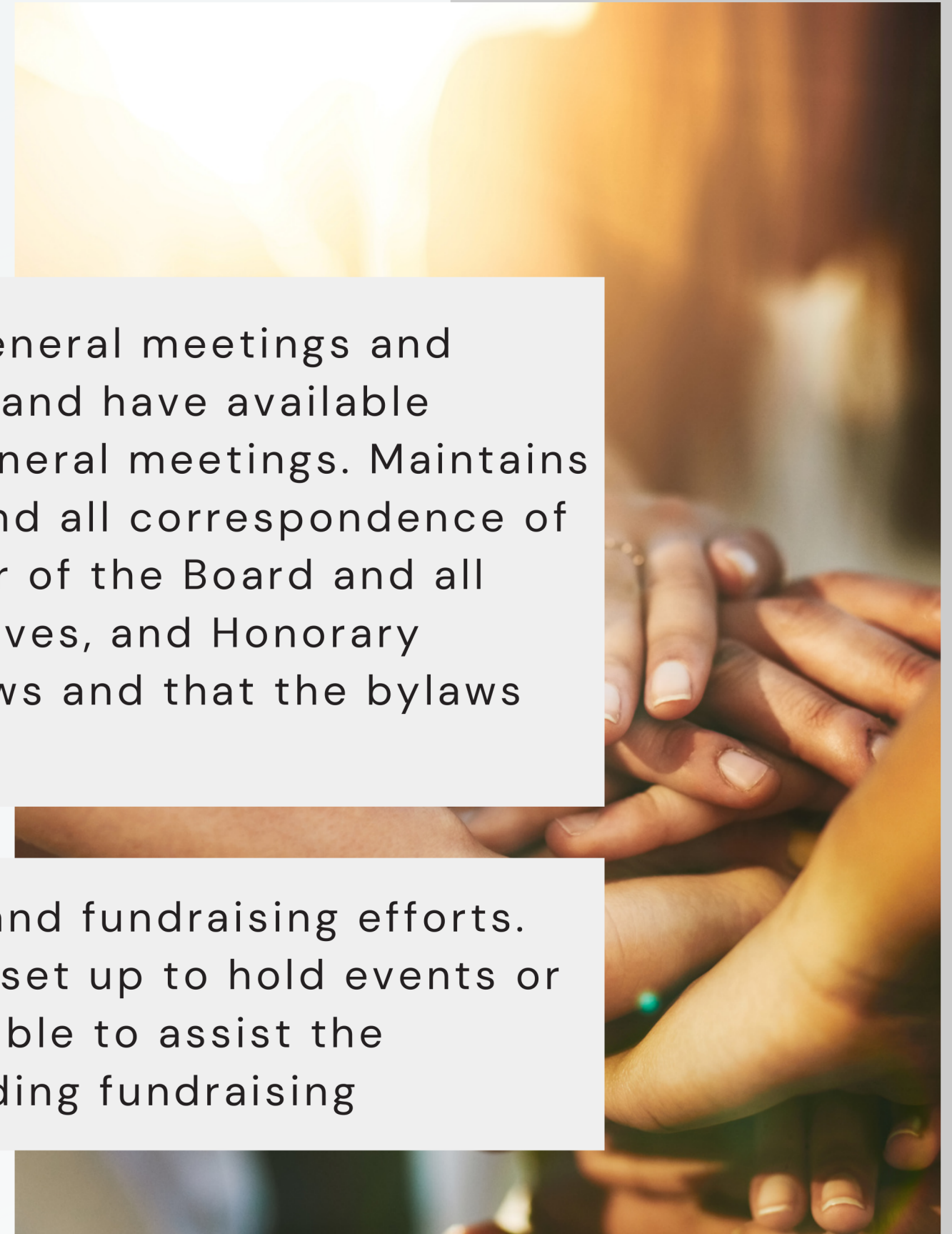
ROLES



Secretary: Keep a book of minutes of all general meetings and meetings of the Board of Directors. Obtain and have available Robert's Rules of Order at all Board and General meetings. Maintains the Articles of Incorporation, the Bylaws, and all correspondence of the Corporation. Ensures that each member of the Board and all General, Member Booster Club representatives, and Honorary members are presented a copy of the Bylaws and that the bylaws are read and understood.



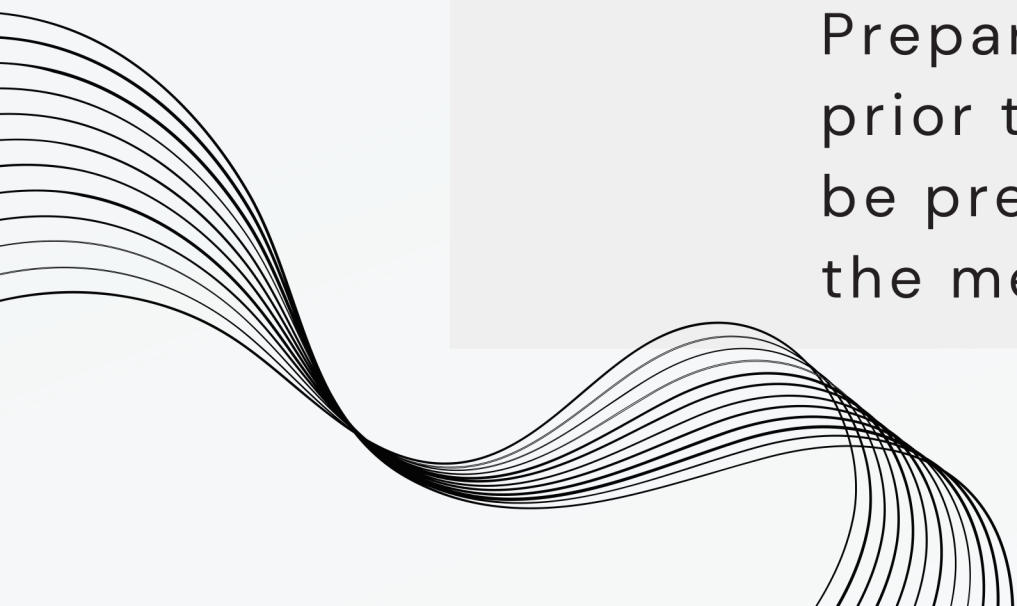
Director of Activities: Oversees all events and fundraising efforts. Automatically a member of any committee set up to hold events or conduct fundraising. Oversees and is available to assist the Member Booster Clubs, if so needed, regarding fundraising



ROLES



Treasurer: Maintains full and complete accounts of the properties and Finances of the Corporation. Prepares a monthly report of all income & expenditures and present this report at the regular meetings. Shall submit for inspection all books and records of income and expenses on written demand, within five (5) days of demand. Cause to be prepared and filed all financial reports required by the State and Federal Government. Responsible for directly working with all Member Booster Clubs to facilitate the reporting of all financial activities. Set forth a format that all Member Booster Clubs shall be required to use to report at each General Meeting any activity in their individual checking account. Prepares an annual budget, pending Board of Directors approval prior to the first meeting of the school year, where the budget will be presented to the General Membership. A 2/3 approval vote by the membership will ratify the budget.



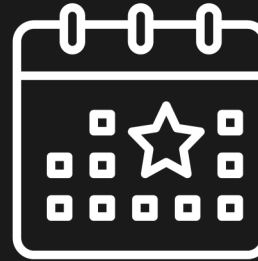
